Narrative description of incident:

The Jackson Police Department's Vice and Narcotics K-9 Unit along with other members of the Jackson Police Department SWAT Team were observing the 1700 block of Jones Street in reference to searching for suspect that was possibly involved with a homicide that occurred earlier that morning on Hill Avenue. Once detectives made a right turn onto Jones Avenue from Valley Street detective noticed a black female at driver's side door of a white Chevy Impala parked in front of 1729 Jones Avenue. Detective observed her clutching US Currency inside her right hand as she leaned inside the driver's side window. Detective pulled behind the vehicle and exited to conduct a field interview due to observing what was possibly a hand to hand transaction. Once detective approached the vehicle the female quickly walked away. At that time detective made contact with suspect and noticed a large amount of US Currency scattered throughout his vehicle. Once he noticed detective he began reaching towards the middle console area. detective gave him loud verbal commands to see his hands and he ignored each command. Detective then advised him to exit the vehicle for Officer Safety in which he ignored and began tucking both hands between the seat as he twisted his body towards the center console away from detective. Detective was unable to see the front of his body and his hands at that time. At that time detective unholstered duty weapon not knowing what he was attempting to retrieve. Detective attempted to remove the suspect from the vehicle for Officer Safety while continuously giving loud verbal commands to exit the vehicle. The suspect still refused to comply with commands and jerked away. With assistance from detective, detectives were able to remove the suspect from the vehicle and place him on the ground. He pulled and jerked away and placed his hands underneath him while tucking his head towards his chest area while on the ground. Detectives were finally able to gain control of the suspect's right hand and place a handcuff on it. Detective brought his left hand to the other handcuff and at that time he was arrest. At that time detectives stood the suspect up and patted him down for any weapons and noticed minor scratches on the right side of his face that were caused during him resisting on the ground. Detective immediately contacted AMR and requested them to the scene to check the minor injuries sustained. The suspect advised that he didn't need AMR and that he was fine he just wanted to go home. Detective advised him that they would still need them to check him. AMR arrived on scene a short time later and treated him for his minor injuries. Suspect advised medical personnel that he didn't want to be transported to the hospital and that he was fine and refused any further treatment. Due to the suspect only having misdemeanor charges, detective arrested him and issued a field released on the charges of failure to obey and resisting arrest.
